## **HOW TO REGISTER TO VOTE & VOTE IN AN ELECTION**

Below you will find the basic steps that must be taken to become a voter and cast a ballot in an election. You will need to contact the Registrar of Voters in your state to learn about any additional state requirements. You may also visit the U.S. Election Assistance Commission or visit your secretary of state's homepage.

## QUALIFICATIONS TO BECOME A VOTER

The U.S. Constitution sets requirements for voter eligibility that must be adhered to by every state. You will qualify to register to vote if you meet all the following requirements:

- 1. You are a citizen of the United States.
- 2. You are at least eighteen years of age by the date of the election.
- 3. You are not imprisoned or on parole for conviction of a felony (this varies from state to state).
- You have not been judged by a court to be mentally incompetent to register and vote. For more information, read the National Voter Registration Act.
- You have registered to vote within your state's required number of days before the election. Request this information from the registrar of voters or visit your secretary of state's website for details.

### HOW TO REGISTER OR PRE-REGISTER TO VOTE

To begin, check the **requirements to vote** to find out if you may register to vote in California.

# In California, if you are 16 years old or older, you are able to pre-register to vote, so when you turn 18, you are all set to vote.

Californians must be registered to vote at least 15 days before Election Day. If the registration deadline has passed for an upcoming election, in most elections you may still be able to register to vote. Visit the CA Secretary of State's website for more information.

Once you register, you may vote in all state and local elections. You will not need to register to vote again unless you change your name or change your political party preference. If you move, you can update your California residence address by re-registering to vote. If you have already updated your residence address at the Department of Motor Vehicles or the U.S. Postal Service, your registration will be automatically updated with your new address.

## WHERE DO YOU REGISTER TO VOTE?

Register to vote ONLINE at registertovote.ca.gov

OR you may pick up a PAPER voter registration application at any DMV and most post offices, public libraries, and government offices.

#### HOW WILL I IDENTIFY MYSELF WHEN REGISTERING TO VOTE?

To register, you will be asked for basic personal information, including but not limited to: First name, Middle name, Last name, Suffix: Jr. / Sr. / II / III / IV, Email, Phone number, Date of birth (MM/DD/YYYY), Place of birth, California Driver License Number or Social Security Number, Street address, City, State, Zip, and County

## VOTING IN AN ELECTION

Visit www.vote.org/polling-place-locator/ to find the location of the polling site where you will be casting your ballot.

When you arrive at the polling site, you will be directed to a table to check in. Your name will be checked against the voter registration list and you will be handed a ballot. A poll worker will direct you to the voting equipment used by your polling site. When you have completed the voting process, a poll worker will usually offer you an "I Voted" sticker that indicates you have fulfilled your civic duty.

## **Proposition 5**: PROPERTY TAX TRANSFER INITIATIVE

YES	A "yes" vote supports amending Proposition 13 (1978) to allow homebuyers who are age 55 or older or severely disabled to transfer their tax assessments, with a possible adjustment, from their prior home to their new home, no matter (a) the new home's market value; (b) the new home's location in the state; or (c) the buyer's number of moves.
<u>NO</u>	A "no" vote opposes amending Proposition 13 (1978) to change how tax assessments are transferred between properties for homebuyers who are age 55 or older or severely disabled.

## <u>Proposition 6</u>: VOTER APPROVAL FOR FUTURE GAS AND VEHICLE TAXES AND 2017 TAX REPEAL INITIATIVE

YES	A "yes" vote supports this initiative to: (a) repeal fuel tax increases and vehicle fees that were enacted in 2017, including the Road Repair and Accountability Act of 2017 (RRAA) and (b) require voter approval (via ballot propositions) for the California State Legislature to impose, increase, or extend fuel taxes or vehicle fees in the future.
NO	A "no" vote opposes this initiative, thus: (a) keeping the fuel tax increases and vehicle fees that were enacted in 2017, including the Road Repair and Accountability Act of 2017 (RRAA), in place and (b) allowing the state legislature to continue to impose, increase, or extend fuel taxes or vehicle fees through a two-thirds vote of each chamber and without voter approval.

## Proposition 7: PERMANENT DAYLIGHT SAVING TIME MEASURE
